### **Dive Photography Competition Terms and Conditions**

#### **A. How to Participate?**

The Competition is open from 8 June 2017 to 5 July 2017 ("Competition Period").

Employees of Resorts World Sentosa and their immediate family members are not eligible to participate in the Competition.

To participate, you must be thirteen (13) years old or above, and (b) have a valid Facebook account and (c) enter the Competition in your own name. If you have not already registered for your free Facebook account, you may sign up for one by following the instructions on [www.facebook.com](http://www.facebook.com).

To participate, you must upload one (1) Competition photo, which reflects the Competition Theme.

You must upload the Competition photo no later than 11.59 p.m. on 5 July 2017 (Singapore time). All Competition photos need to be uploaded on the designated Facebook photo album on S.E.A. Aquarium Society Facebook group in order to qualify for participation.

Resorts World Sentosa reserves the sole and absolute discretion to exclude or disqualify any Participant and/or entry from the Competition.

#### **B. Photo Requirements**

The theme of the Competition is 'Marine Bioiversity' ("Competition Theme").

The Competition photo must be taken on or after 1 January 2017, in JPEG format.

The Competition photo must be saved in RGB colour model.

The Competition photo must retain the original intact EXIF (EXCHANGEABLE IMAGE FILE FORMAT) data.

The Competition photo may only undergo minor post-processing, such as cropping and adjustment of exposure, white balance and saturation.

Upon request, participants must be able to supply Resorts World Sentosa with high resolution Competition photos that are suitable for printing.

#### **C. Winners and Prizes**

Each Competition photo entry will be judged by a panel between 6 and 12 July 2017.

Three (3) Competition photo entries from the list of entries will be selected by the judging panel as the Jury's top three (3) winning entries.

A Competition photo entry will also be selected as the Viewer's Choice winning entry. The Viewer's Choice winning entry will be determined based on the highest number of public "Likes" achieved on the original uploaded photo by 11.59 p.m. on 25 June 2017, at S.E.A. Aquarium Society Facebook group. In the event

of a tie, Resorts World Sentosa shall, in its sole discretion, select the Viewer's Choice winning entry based on the creativity of the Competition photo entries and other criteria that Resorts World Sentosa in its sole discretion deem appropriate.

The Jury's Choice and Viewers' Choice winning entries ("Winners") will be announced at Resorts World Sentosa's Facebook page at <https://www.facebook.com/groups/seaaquariumsociety> on 14 July 2017.

The Winners will be notified by Resorts World Sentosa via phone and/or email within fourteen (14) days of the announcement of the Winners, and given details on how to claim their Prizes (as defined below).

In the event that a Winner (i) does not respond to Resorts World Sentosa within fourteen (14) days of being notified by Resorts World Sentosa; or (ii) fails to collect the Prize within three (3) months from announcement of the Winners; or (iii) breached any Terms and Conditions herein; or (iv) his/her Competition photo entry is invalid for whatever reasons, his/her Prize will be forfeited and Resorts World Sentosa shall be entitled in its sole discretion to select another Winner.
