

RWS Restricted**Terms and Conditions Governing Summer of Treasures Promotions**

These terms and conditions (the “Terms”) govern and apply to the following Summer of Treasures promotions (collectively, the “Promotions”) organised by Resorts World at Sentosa Pte. Ltd. (“RWS”):

- A. **Summer of Treasures, Scratch Card Campaign** (the “Scratch Card Campaign”); and
- B. **Resorts World Sentosa x Coca-Cola, FIFA World Cup 2026** (the “Coca-Cola Lucky Dip”).

1. Eligibility

1.1 **General Eligibility.** The Promotions are open to all guests who are at least **eighteen (18) years of age** (“Participants”).

1.2 **Ineligible Persons.** The following persons are **not eligible** to participate:

- RWS employees, contractors, and tenant staff (including any persons involved in or assisting with issuance, administration and/or redemption of the Promotions); and
- Any other person that RWS designates as ineligible at its sole discretion.

1.3 **Discretionary Exclusion.** RWS may, at its sole and absolute discretion, **exclude** any person from participation at any time (including without limitation for suspected fraud, abuse, manipulation, collusion or breach of these Terms, or conduct prejudicial to the integrity of the Promotions) without prior notice and without obligation to provide reasons. Any entitlement held by an excluded person shall be immediately forfeited.

1.4 **Age verification.** RWS and its representatives reserve the right to require proof of age and/or identity at any time. Failure to produce satisfactory proof shall entitle RWS to refuse or revoke participation and/or any prize

2. Promotion Period

2.1 The Promotions shall run from **29 May 2026 to 30 August 2026**, both dates inclusive (the “Promotion Period”). All eligible transactions, collection of scratch cards, and redemption of prizes must be completed within the Promotion Period, and no later than the operating hours on 30 August 2026, failing which they shall be deemed invalid.

Unless otherwise specified for particular prizes, the utilisation of prizes may take place after the Promotion Period but must be completed by 30 September 2026. Notwithstanding the foregoing, certain specified prizes shall be subject to an extended booking window, with bookings to be made by February 2027.

2.2 RWS reserves the right to extend, shorten, or otherwise vary the Promotion Period at its sole discretion without prior notice.

3. Scratch Card Campaign — How to Qualify

3.1 **Entitlement per transaction.** During the Promotion Period, a Participant may be entitled to receive **one (1) scratch card** (a “Scratch Card”) per **eligible onsite transaction / original printed receipt** at participating locations within Resorts World Sentosa (the “Eligible Transaction”), with no minimum spend required.

3.2 **One (1) Scratch Card per receipt.** One (1) Scratch Card per Eligible Transaction / per printed receipt. There is no per-person limit, subject to Clause 3.6 (availability). Each printed receipt may only be used **once** for Scratch Card issuance and may be marked/stamped upon issuance to prevent reuse. Any attempt to use a previously stamped or used receipt shall be treated as abuse and may result in disqualification under Clause 1.3.

3.3 **Onsite spend only.** Online, offsite, or non-onsite transactions do not qualify.

3.4 **Non-qualifying transactions.** The following **do not qualify** for Scratch Card entitlement:

- attraction admission tickets;
- attraction express passes;
- Employee Perks, Casino Vouchers, Gift Vouchers, and Genting Dollars (GD); and
- any receipts comprising solely the purchase of cigarettes and/or alcohol

3.5 **Same-day requirement.** Only receipts from transactions made **on the same calendar day** as the Scratch Card issuance/collection attempt will be accepted. Receipts from prior days will not be honoured under any circumstances.

3.6 **Daily availability; No guarantee of Supply.** Scratch Cards are available **daily on a first-come, first-served basis while stocks last**. Allocation may vary by location. RWS may limit issuance at any time without prior notice.

4. Scratch Card Campaign — Scratch & Win Mechanics

4.1 **Maximum one prize per Scratch Card.** Each Scratch Card displays multiple prize rows; however, each Scratch Card entitles the Participant to win a maximum of one (1) prize only.

4.2 **Winning condition.** Participants must scratch the play area. A Scratch Card is a winning card only if it reveals **three (3) identical icons in a row**, in which case the Participant wins the **corresponding prize** for that row.

4.3 **Outcome final and binding.** The prize outcome revealed on the Scratch Card is **final and binding**. RWS will not entertain any request for exchange, re-draw, re-scratch or substitution by a Participant, except where expressly stated in Clause 7.3 (prize substitution by RWS).

5. Scratch Card Campaign — How Scratch Cards Are Issued

5.1 All Scratch Card collection points under the Scratch Card Campaign are listed in Table A.

5.2 **Signature restaurants.** Scratch Cards may be issued at the restaurant **after payment** for an Eligible Transaction, subject to availability.

5.3 **WEAVE outlets.** Participants must present their **same-day original printed receipt** at the designated **WEAVE Level 1 Redemption Booth** to collect the Scratch Card, subject to availability.

5.4 **In-park (attractions) spends:** Scratch Cards may be issued at **designated outlets** within each attraction (e.g., Universal Studios Singapore, Singapore Oceanarium, Adventure Cove Waterpark), as determined by RWS from time to time. RWS reserves the right to add, remove, or change designated outlets without prior notice.

5.5 **Hotel guests (check-out):** Scratch Cards may be issued to eligible hotel guests **upon check-out**, after the guest **completes a review/feedback** in accordance with instructions provided by RWS and **verifies completion** with the hotel front desk staff, subject to availability. Entitlement is **one (1) Scratch Card per completed review/feedback**. This clause governs hotel check-out Scratch Card issuance and supersedes any general reference elsewhere in these Terms.

6. Scratch Card Campaign — Prize Redemption

6.1 **Redemption Period for Scratch Card Prizes.** Scratch Card prizes must be claimed/redeemed **within seven (7) days** from the date the Scratch Card is issued or collected, and in any case during the applicable operating hours of the designated redemption location. Claims submitted after such 7-day period, or after operating hours on the last eligible day, will not be honoured under any circumstances, and the prize shall be deemed forfeited without any compensation.

6.2 **Redemption routes.** Prizes are redeemed via the applicable channel indicated for the relevant prize:

- **WEAVE Level 1 Redemption Booth (collection):** Certain prizes must be collected at the WEAVE Redemption Booth (Level 1), as indicated for the prize; or
- **Participating outlet (on-site redemption):** Certain prizes must be redeemed directly at the stated participating outlet by presenting the Scratch Card, as indicated for the prize.

6.3 **Operating hours.**

- For prizes collected at the WEAVE Redemption Booth: redemption is available between **11:00am to 9:00pm daily**, subject to change without prior notice.
- For prizes redeemed at participating outlets: redemption is subject to the **respective outlet's operating hours, which may vary.**

6.4 **Original Scratch Card required and retention.** Participants must present the **original physical Scratch Card** to redeem a prize. Upon successful redemption, the Scratch Card will be **retained/collected** by the redemption staff/outlet upon successful redemption. Photocopies, digital images (including screenshots and photographs), or any altered, tampered or reproduced Scratch Cards will not be accepted. RWS reserves the right to invalidate any Scratch Card it reasonably suspects has been tampered with, duplicated, or fraudulently presented.

- 6.5 **Receipt requirements (where applicable).** Where an original printed receipt is required for Scratch Card collection at the WEAVE Redemption Booth:
- Only **original printed receipts** are accepted;
 - **Official POS reprinted receipts** issued by the respective outlet are acceptable; and
 - Receipts that are torn, defaced, altered or illegible may be rejected by RWS in its sole discretion.
- 6.6 **No replacement.** Lost, stolen, damaged, or defaced Scratch Cards will **not** be replaced under any circumstances, and any prize associated with such Scratch Cards will be deemed irrevocably forfeited.
- 6.7 **Use vs. claim.** Scratch Card prizes must be **claimed/redeemed within seven (7) days** from the date of issuance or collection, in accordance with Clause 6.1. Unless otherwise stated, the actual use or consumption of any voucher, ticket, stay, or benefit may take place after redemption but must be completed by 30 September 2026 (being approximately one (1) month after the end of the Promotion Period). All prizes remain subject to applicable validity periods, blackout dates, booking requirements, outlet policies, and/or other prize-specific terms (see Clause 7), and the right to use any prize is conditional upon compliance with such terms
- 6.8 **Unclaimed prizes forfeited.** Any prize not claimed within the applicable timeframe shall be deemed forfeited, and RWS shall have no obligation to hold, carry forward, or otherwise preserve such prize for the Participant. RWS shall not be required to notify Participants of unclaimed prizes

7. Scratch Card Campaign — Prizes & Prize-Specific Terms

- 7.1 Prizes available under the Scratch Card Campaign are listed in **Table B** at the end of these Terms. Table B is subject to change at RWS's sole discretion.
- 7.2 **Prize-specific terms apply.** Any additional terms stated in Table B, on the Scratch Card, on the voucher/ticket, at the WEAVE Level 1 Redemption Booth, at the participating outlet, and/or on official campaign materials will apply.
- 7.3 **Substitution.** RWS reserves the right, in its sole and absolute discretion and without any prior notice, to substitute any prize with another prize of similar value, in particular where a prize is discontinued, unavailable, or otherwise cannot be fulfilled. No Participant shall have any right to object to or seek compensation in connection with any substitution.
- 7.4 **Transferability.** Prizes are **generally non-transferable** unless explicitly stated otherwise in the relevant prize-specific terms. Where a prize is stated to be transferable, the original redemption Participant remains responsible for ensuring that the recipient complies with all applicable prize-specific terms. Any transfer in contravention of these Terms shall render the prize void.
- 7.5 **No resale / commercial use.** Prizes must not be sold, bartered, auctioned, transferred for value or used for commercial purpose. Any prize found to have been so used may be revoked, and the relevant Participant may be subject to disqualification and/or legal action.
- 7.6 **No cash equivalent.** Prizes have no cash redemption value and cannot be exchanged for cash, credit, or any other form of consideration, except as expressly stated by RWS.
- 7.7 **Tax obligations.** Participants are solely responsible for any and all taxes, levies, duties, or assessments (including income tax, goods and services tax (GST), or any other applicable tax) arising from or in connection with receipt or use of any prize.

RWS Restricted**8. Coca-Cola Lucky Dip — How to Qualify**

8.1 **Qualifying Condition.** During the Promotion Period, a Participant may be entitled to **one (1) Lucky Dip Chance** per qualifying receipt (the “**Lucky Dip Chance**”) if the Participant purchases **at least two (2) Coca-Cola** participating beverages/brands **in the same transaction on the same printed receipt.**

8.2 **Coca-Cola participating beverages/brands** include:

- Coca-Cola
- Sprite
- Fanta
- A&W
- Schweppes
- Minute Maid
- Fuze Tea
- Authentic Tea House

RWS reserves the right to add or remove participating brands without prior notice.

8.3 Lucky Dip Chances are available daily on a first-come, first-served basis while stocks last. RWS does not guarantee availability at any time and may suspend or terminate the Lucky Dip at any time without prior notice.

8.4 **Same-day redemption only.** Participants must redeem the Lucky Dip Chance **on the same calendar day of purchase** at the designated WEAVE Redemption Booth (subject to operating hours). No carry-over or deferred redemption will be permitted.

9. Coca-Cola Lucky Dip — Redemption & Prizes

9.1 **Redemption Process.** To redeem, Participants must present their same-day printed receipt showing the qualifying purchase at the designated WEAVE Level 1 Redemption Booth. RWS reserves the right to verify the receipt and to decline any claim where the receipt is suspected to be invalid, altered, or previously used.

9.2 **Prizes.** Lucky Dip prizes include **RWS x Coca-Cola co-branded cans** and “**10 countries football bears**” (or such other Coca-Cola promotional items as determined by RWS from time to time), **while stocks last.** RWS makes no representation as to the specific item a Participant will receive.

9.3 **Outcome Final, No exchange.** Lucky Dip prizes are issued on a **random** basis. All outcomes are final and binding. No exchange, substitution or appeal will be entertained, except at RWS’s sole discretion. RWS’s decision on any matter relating to the Lucky Dip is final and conclusive.

10. Using the Same Receipt for Both Promotions

10.1 Where a receipt qualifies for both one (1) Scratch Card (Scratch Card Campaign) and one (1) Lucky Dip Chance (Coca-Cola Lucky Dip), the Participant may redeem **both entitlements** using the same qualifying receipt, subject to availability and these Terms. Each entitlement remains subject to its respective conditions.

11. Personal Data & Publicity

11.1 **No registration forms generally required.** Participation and prize claim generally require only presentation of the applicable **printed receipt** and/or **original Scratch Card**. No redemption form is ordinarily required (unless RWS notifies otherwise for specific prize fulfillment).

11.2 Consent to personal data collection. By participating, each Participant consent to RWS and its authorised agents collecting, using, and disclosing any personal data incidentally captured (e.g., via CCTV footage at redemption points, identity/age verification records) or as otherwise provided in connection with the Promotions, for the purposes of administering the Promotions, verifying eligibility, preventing fraud and/or complying with applicable law, in accordance with RWS's Personal Data Protection Statement: <https://www.rwsentosa.com/en/personal-data-protection>

11.3 Publicity Consent. Participants acknowledge and agree that RWS may be photograph, film or record Participants at or in connection with the Promotions (including at redemption points), and irrevocably consent to RWS using such image, likeness or recording for marketing, publicity, social media and/or promotional purposes without compensation, credit or further notice to the Participant, to the fullest extent permitted by applicable law.

11.4 Intellectual property. All intellectual property rights in the Promotions, including but not limited to the name "Summer of Treasures"; Scratch Card designs, marketing materials, creative works, and any content produced in connection with the Promotions, vest in and remain the exclusive property of RWS (or its licensors). Participants shall not reproduce, distribute, or use any such intellectual property without RWS's prior written consent

12. Fraud, Abuse, and Verification

12.1 Right to verify. RWS reserves the right, at any time, to verify eligibility of any Participant, the validity of any receipt, Scratch Card or Lucky Dip redemption and/or the authenticity of any claim. Participants must cooperate fully with any verification request. Failure or refusal to cooperate may result in disqualification.

12.2 Grounds for rejection and disqualification. RWS may reject a claim and/or disqualify a Participant where:

- Any receipt or Scratch Cards is suspected to be forged, altered, duplicated, stolen, illegible or otherwise invalid;
- RWS reasonably suspects fraud, abuse, manipulation, collusion or breach of these Terms; or
- A Participant has provided false or misleading information in connection with the Promotions.

12.3 Forfeiture and clawback. Any Participant found to have cheated, committed fraud or otherwise abused the Promotions will be disqualified and any unredeemed entitlement will be immediately forfeited. Where a prize has already been issued to such a Participant, RWS reserves the right to **demand return of or compensation for the value of the prize**, and the Participant shall comply forthwith.

12.4 Legal action. RWS reserves the right to pursue civil and/or criminal proceedings against any Participant or third party involved in fraud, forgery, unauthorised duplication, or any other dishonest conduct in connection with the Promotions.

13. Limitation of Liability and Indemnity

13.1. Exclusion of liability. To the fullest extent permitted by applicable law, RWS, its related corporations, officers, employees, agents, contractors, and licensors (collectively, the "**RWS Parties**") shall not be liable to any Participant or third party for any:

- personal injury or death arising from participation in or redemption of any Promotion, except where caused by RWS's gross negligence or wilful misconduct;
- loss of profits, business, revenue, goodwill, data, or savings;
- indirect, consequential, incidental, special, exemplary, or punitive damages; or
- any loss or damage arising from technical failures, printing errors, Scratch Card defects, acts of God, interruptions, delays, or circumstances beyond RWS's reasonable control,

in each case whether or not such loss or damage was foreseeable or RWS had been advised of its possibility.

13.2. **Maximum liability.** Without prejudice to Clause 13.1, the aggregate liability of the RWS Parties to any single Participant in connection with any Promotion shall not exceed the face value of the relevant prize won by that Participant.

13.3. **Participant indemnity.** Each Participant shall **indemnify, defend, and hold harmless** the RWS Parties from and against any and all claims, demands, actions, losses, liabilities, costs, and expenses (including legal fees on a full indemnity basis) arising out of or in connection with: (a) the Participant's participation in or use of any prize from the Promotions; (b) the Participant's breach of these Terms; (c) the Participant's fraud or wilful misconduct; or (d) any third-party claim arising from the Participant's actions or omissions in connection with the Promotions.

14. Variation, Suspension and Cancellation

14.1. RWS reserves the right, in its sole and absolute discretion and **without prior notice**, to change, suspend, withdraw, cancel, or terminate any or all Promotions and/or to amend these Terms at any time. Amendments to these Terms take effect from the date of posting on official RWS channels unless otherwise stated.

14.2. RWS's decisions on all matters relating to the Promotions (including eligibility, prize claims, and outcomes) are **final and conclusive**. No correspondence, negotiation, or appeal will be entertained.

15. General Provisions

15.1 **Acceptance of Terms.** Participation in any Promotion constitutes full and unconditional acceptance of these Terms and any instructions issued by RWS from time to time.

15.2 **Third Parties (Rights of Third Parties).** A person who is not a party to these Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 (Singapore) to enforce any provision of these Terms.

15.3 **Precedence.** In the event of any inconsistency or conflict between these Terms and any marketing, promotional, or advertising materials (including social media posts), **these Terms shall prevail**. Where there is inconsistency between the general provisions of these Terms and any prize-specific terms in Table A or on a voucher/ticket, the prize-specific terms shall prevail only to the extent of such inconsistency.

15.4 **Severability.** If any provision of these Terms is found by a court of competent jurisdiction to be invalid, unlawful, or unenforceable, such provision shall be severed and the remaining provisions shall continue in full force and effect.

15.5 **No waiver.** Any failure or delay by RWS to exercise or enforce any right or remedy under these Terms shall not constitute a waiver of that right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy.

15.6 **Entire agreement.** These Terms (together with any prize-specific terms incorporated by reference) constitute the entire agreement between RWS and each Participant with respect to the Promotions and supersede all prior representations, warranties, understandings, or arrangements relating to the same.

15.7 **Governing law and jurisdiction.** These Terms shall be governed by and construed in accordance with the laws of the Republic of Singapore. The Courts of Singapore shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Terms.
