

RWS Confidential**RWS COMPLIMENTARY PARKING COUPON PROMOTION****16 Feb – 3 Mar 2026****Terms and Conditions Governing the RWS Complimentary Parking Coupon Promotion**

The following terms and conditions ("the Terms") shall apply to the RWS Complimentary Parking Coupon Promotion (the "Promotion") organized by Resorts World at Sentosa Pte. Ltd. ("RWS").

Eligibility

1. This Promotion is open to all guests who are at least eighteen (18) years of age ("Participants"), except any RWS employees, contractors and/or agents who assist with the Promotion redemption at the Redemption Booth.
2. Participants must present a valid government-issued identification for verification of identity and age upon request.
3. RWS has the sole and absolute discretion to exclude any person from participating in the Promotion (including but not limited to a person who fails to provide true, correct, complete and accurate information) without any obligation to furnish any notice and/or reason.

Duration of the Promotion

4. The Promotion will commence on 16 February 2026 and end on 3 March 2026, both dates inclusive (the "**Promotion Period**").

Promotion Mechanics

5. Participants must make a purchase at any retail or food & beverage stores within Resorts World Sentosa to redeem one (1) complimentary parking coupon (the "**Coupon**"). The following receipts are not accepted for this Promotion:
 - a. Attraction ticket purchases;
 - b. Hotel stays;
 - c. Event booking deposits or instalments;
 - d. Purchases made with RWS employee credits (i.e. TM perks);
 - e. ATMs or money changer receipts;
 - f. Purchase or redemption of RWS Gift vouchers;
 - g. Top-ups or reloads of cashcard(s) or other stored-value card(s);
 - h. Membership or loyalty programme fees;
 - i. AXS/SAM machine transactions, bill payments, interest charges, service fees, delivery fees and administrative fees;
 - j. Purchase of lottery tickets/cigarettes/liquor from 7-Eleven;
 - k. Receipts from HMI-MHC Medical Clinic (#B2-01);
 - l. Transport fees or parking charges; or
 - m. Casino entry levy.
6. The Coupon entitles the Participant to free parking at Resorts World Sentosa Carpark for the first 4 hours. Standard parking rates shall apply after the first 4 hours of free parking, commencing with the applicable first-hour charge. No grace period shall apply.
7. For the avoidance of doubt, Participants must remove their cash card from their IU/OBU prior to approaching the exit gantry to avoid incurring additional charges. Please note only one (1) Parking Coupon may be used per exit.

8. RWS reserves the right to change or amend the details and/or mechanics of the Promotion, at its sole and absolute discretion.

Redemption Mechanics

9. Participants must redeem the Coupon on the same day of purchase at the Redemption Booth located at WEAVE, Level 1, from 11am to 9.15pm (last redemption timing). RWS reserves the right to refuse any redemption request submitted after 9.15pm.
10. To redeem the Coupon, Participants are to present their original receipts at the Redemption Booth for validation.
11. Only original printed receipts are accepted for redemption. Credit card/NETS charge slips, handwritten, duplicate or re-print receipt(s) will not be accepted.
12. Receipts that are torn, defaced, altered or illegible, including receipts where transaction details are faded or unclear, will not be accepted.
13. For the avoidance of doubt, receipts used for the redemption of Coupon(s) under this Promotion cannot be used for any other promotions.
14. Limited to one (1) redemption of Coupon per Participant per day.
15. Redemption of Coupon(s) are on a first-come, first-served basis and are subject to availability.
16. The Coupon is not for sale, not transferable, non-refundable and not exchangeable for cash or other benefits, even in cases of non-utilisation or partial utilization. The Coupon is also void if altered. Lost, damaged, defaced, stolen, expired and/or void Coupons will not be replaced.
17. The specific terms and conditions of the Coupon shall apply.

General

18. By participating in the Promotion, the Participant is deemed to have accepted and agreed to be bound by these Terms and any other instructions, terms and conditions that RWS may issue from time to time.
19. RWS shall not be liable for any injuries, losses or damages in respect of, in connection with and / or arising from the Promotion and/or the Coupon, including but not limited to the Participant's redemption and use of the Coupon, lost, stolen or expired Coupons, system errors, technical failures, or unavailability of redemption, regardless of whether such damage or loss is caused by RWS's negligence or otherwise. The Participants agree that the redemption and usage of the Coupons are entirely at their own risk.
20. RWS reserves the right to disqualify any Participants from the Promotion for fraud, manipulation or other related issues, including providing false information (such as fake account(s), personas or photos) or for deliberately withholding information.
21. RWS reserves the right to change, suspend, withdraw or cancel the Promotion and to amend these Terms at any time in its sole discretion without giving prior notice to the Participants. The decision of RWS on all matters relating to or in connection with the Promotion is final, and no correspondence will be entertained.
22. The Participant shall fully indemnify and hold RWS harmless from and against any loss, damage, cost, liability, or expense (including legal fees), whether direct or indirect, which RWS may incur arising out of or in connection with the Participant's breach of these Terms.

23. A person who is not a party to any agreement governed by these Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001, including but not limited to the enforcement of any of these Terms.
24. In the event of any inconsistencies or discrepancies between the Terms and the contents of any brochure, marketing and/or promotional materials relating to the Promotion, these Terms shall prevail.
25. The Terms shall be governed by and interpreted in accordance with Singapore law without regard to its principles of conflicts of laws. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms, including the validity and enforceability thereof.
