### Terms and Conditions Governing the 'In The Bunnyverse' Giveaway

The following terms and conditions (the “**Terms**”) shall apply to the ‘**In The Bunnyverse**’ Giveaway organized by Resorts World Sentosa Pte. Ltd. (“**RWS**”) (the “**Giveaway**”).

#### Eligibility

1. This Giveaway is open to all members of the public (“**Participants**”) who are at least eighteen (18) years of age.
2. Participants must present valid government-issued identification for verification of identity and age upon request.
3. RWS has the sole and absolute discretion to exclude any person from participating in the Giveaway (including but not limited to a person who fails to provide true, correct, complete and accurate information) without any obligation to furnish any notice and/or reason.

#### Duration of the Giveaway

4. The Giveaway will commence on 1 April 2023 and end on 31 December 2023, both dates inclusive (the “**Giveaway Period**”).

#### Participation Mechanics

5. To participate in the Giveaway, Participants must, by no later than 31 December 2023, 2359hrs:
  - a. Follow the @rwsentosa accounts on Instagram, TikTok or Xiao Hong Shu (Red); and
  - b. Post a photo/video of themselves with the Bunnyverse bunnies and tag @rwsentosa and the hashtag #RWSBunnyverse

(the “**Giveaway Entry**”)

6. Participants must have an active account on the relevant social media platform, and have their social media account/post privacy setting set as “public” during the Giveaway Period.
7. Participants may accumulate multiple chances by posting more than one (1) photo/video, but each Participant shall be limited to winning a maximum of one (1) Prize during the Giveaway Period.
8. The Giveaway is open to participants from all countries.
9. RWS reserves the right to change or amend the details and/or mechanics of the Giveaway, at its sole and absolute discretion.

#### Giveaway Mechanics

10. The selection of winners for Giveaway Entries posted in each month will be conducted on the first Monday of the following month (excluding Public Holidays) (the “**Selection Date**”). Should the first Monday of the month fall on a Public Holiday, the selection of winners shall be conducted on the subsequent Monday. For example, the Selection Date for Giveaway Entries posted in May 2023 shall be Monday, 5 June 2023. The final set of winners will be contacted in January 2024.
11. The most creative submissions as deemed by RWS, shall be selected as winners each month.
12. Three (3) unique winners will be selected each month.

### Prizes

13. Each winner shall receive the following Prize as set out below:
  - (a) 2D1N stay at Hard Rock Hotel Singapore (Deluxe Room) for 2 persons (non-peak dates, subject to availability and specific T&Cs), which shall be valid for one (1) year from the date of issuance.
14. The Prize will be issued in the form of a letter/voucher.

### Collection of Prizes

15. The winners will be announced in the comments section of their respective winning Giveaway Entry's social media post within 5 working days of the Selection Date.
16. RWS will communicate via direct message of the relevant social media platform to request for winners to provide their Full Name as per their passport and Email Address for prize redemption. The communication will be in English or Simplified Chinese.
17. Thereafter, RWS will send each winner an email in English or Simplified Chinese with details of the prize including the method of prize redemption.
18. Upon check-in, a prize verification form ("**Prize Verification Form**") will be provided to the winners. Winners shall sign and return the Prize Verification Form to acknowledge receipt of their Prize from RWS.
19. During the selection, RWS reserves the right to choose a number of "reserve winners" to replace any winner subsequently disqualified. The number of "reserve winners" and manner of replacement of winners will be made at RWS's sole and absolute discretion.
20. RWS reserves the right to substitute the Prizes for other prizes of similar value at its sole and absolute discretion, without prior notice.
21. All Prizes are non-transferable, non-exchangeable and non-reimbursable and are subject to availability. The Prizes may not be sold or used for any commercial purpose, including but not limited to any use of which the Participant would be entitled to collect fees or receive any remuneration. RWS will be under no obligation to replace any Prizes that are not utilised by the winners before any expiry date as may be stipulated by RWS .
22. The specific Terms and Conditions of each of the Prizes shall apply.

### General

1. By participating in the Giveaway, the Participant is deemed to have accepted and agreed to be bound by these Terms and any other instructions, terms and conditions that RWS may issue from time to time.
2. RWS shall not be liable to any persons in the Giveaway for any injuries, losses or damages in respect of, in connection with and / or arising from the Giveaway. For the avoidance of doubt, cancellation, termination or suspension by RWS of the Giveaway(s) shall not entitle any party to any claim or compensation against RWS for any and all losses or damage suffered or incurred as a direct or indirect result of the act of cancellation, termination or suspension.
3. Any Participants found cheating will be disqualified from the Giveaway and rendered ineligible to win the Prizes. RWS reserves the right to disqualify any Participants from the Giveaway for fraud,

manipulation or other related issues, including providing false information (such as fake account(s), personas or photos) or for deliberately withholding information.

4. By participating in the Giveaway, all Participants agree to and shall be deemed to have agreed to grant to RWS a non-exclusive, non-transferrable, irrevocable and royalty free licence to use the photo posted for the Giveaway entry for the purposes of marketing the Giveaway.
5. By participating in the Giveaway, all Participants agree and shall be deemed to have agreed to participate in any publicity, advertisement or media coverage as requested or required by RWS, without compensation. RWS reserves the right to video, photograph and / or record the Giveaway (including but not limited to the announcement of the winners and the collection of the Prizes by the winners), and publish any Participants' images and details for any purpose whatsoever without having to pay any fee or compensation to the Participants.
6. RWS reserves the right to change, suspend, withdraw or cancel the Giveaway and to amend these Terms at any time in its sole discretion without giving prior notice to the Participants. The decision of RWS on all matters relating to or in connection with the Giveaway is final, and no correspondence will be entertained.
7. The Participant shall fully indemnify and hold RWS harmless from and against any loss, damage, cost, liability, or expense (including legal fees), whether direct or indirect, which RWS may incur arising out of or in connection with the Participant's breach of these Terms.
8. The Participant hereby grants his/her consent to RWS to collect, use and disclose the Participant's personal data acquired, for the following purposes in accordance with the Personal Data Protection Act 2012 and RWS's Personal Data Protection Statement (available at RWS's website <https://www.rwsentosa.com/en/legal-information>):
  - a. administering this Giveaway, including to contact you for the administration of the prize in relation to this Giveaway;
  - b. verifying your identity;
  - c. responding to, handling, and processing queries, requests, applications, complaint and feedback from you;
  - d. managing your relationship with us;
  - e. processing payment or credit transactions;
  - f. complying with any applicable laws, regulations, codes of practice, guidelines, or rules, or to assist in law enforcement and investigations conducted by any governmental and/or regulatory authority;
  - g. any other purposes for which you have provided the information;
  - h. transmitting to any unaffiliated third parties including our third party service providers and agents, and relevant governmental and/or regulatory authorities, whether in Singapore or abroad, for the aforementioned purposes; and
  - i. any other incidental business purposes related to or in connection with the above.
9. A person who is not a party to any agreement governed by these Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001, including but not limited to the enforcement of any of these Terms.
10. In the event of any inconsistencies or discrepancies between the Terms and the contents of any brochure, marketing and/or promotional materials relating to the Giveaway, these Terms shall prevail.
11. The Terms shall be governed by and interpreted in accordance with Singapore law without regard to the principles of conflicts of laws. The Courts of Singapore shall have exclusive jurisdiction over any disputes arising from these Terms, including the validity and enforceability thereof.
